MEDICARE CHECKLIST



12 MONTHS PRIOR

Lets connect and discuss the road map for the next year!
We will discuss what Medicare is, what to expect when taking action, and what role the Broker has is during this transition.

TO DO LIST

Schedule your first free introductory call



6 MONTHS PRIOR

Beware! You will start to receive a lot of mail and phone calls. It may look and sound official, but most of it is just marketing. We can help drown out the noise.

TO DO LIST

- Schedule a 30 min call for a needs analysis/review
- Review your Medicare and you Booklet
- Create a list of questions, if you have any
- Create a list of medications and doctors



4 MONTHS PRIOR

Mailers, Emails and calls will increase around this time, don't worry you can ignore most of it. Pay close attention to letters / documents from CMS, Medicare and SSA. If you are unsure which is official, call us!

The first deadline to take action is 1 month away (enrolling in Medicare Part B)

TO DO LIST

- Confirm that your doctor accepts original Medicare
- Schedule an appointment to review and approve plans
- Gather documents to enroll in Medicare Part B



3 MONTHS PRIOR

The first enrollment deadline is this NOW, Medicare Part B. Enroll on time to avoid any potential penalties.

Cards will come in the mail and it can take 4-6 weeks to receive them.

Determine if your income qualifies you for extra help or if will you receive an income related adjustment if it is too high.

TO DO LIST

- If you have both Medicare Part A and Part B, time to set enrollment meeting with GMBA Advisors

- Enroll in Medicare Part B if you are not taking Social SecurityBenefits

2 MONTHS PRIOR

Have you enrolled in Medicare Part B?

Have you received your cards?

It is important to enroll in coverage early so that you have your cards in hand and there is no lapse in coverage or the ability to enroll in extra coverage.

TO DO LIST

- Time to enroll in additional coverage and terminate your current coverage

- Set up last meeting with GMBA Advisors Group before your 65th birthday!

- Pay Medicare Part B premiums

You will typically receive a Medicare Advantage or Prescription Drug plan verification call from the carrier no later than 10 days after you enroll.

Be prepared for lots of plan documents to arrive after your enrolled.

There are multiple mailings that must be sent as part of compliance. Not sure what they are when you receive them? Call us.

- Do you have your enrollment checklist for the Medicare Advantage or the PDP Rx Plan call?

- Review all correspondence from the insurance carrier you have enrolled in.

- Review all Carrier, CMS and SSA regulatory mailings

- Schedule your welcome to Medicare Physical
